NEW BUSINESS

- 9. BHS Society Report Doug Brown
 - \rightarrow Society is "holding its own" currently from a financial standpoint
 - cash positive but not by much
 - → The Las Vegas convention went very well, attendance over 7000 for the first time in several years
 - Harmony Marketplace was also better than in 2013
 - → Society is trying to make operations less dependent upon dues and diversify to other sources (e.g. sales of barbershop arrangements)
 - \rightarrow Harmony Foundation is funding many of the external operations
 - ILL District as an organization has not been contributing to the Harmony Foundation...
 - ...Because it's not in our budget and we have not been able to afford it.
 - ILL District membership is financially supportive of the Harmony Foundation
 - Note: grant applications available on BHS website. Note also that there is considerable lead time required
 - \rightarrow New chapter names need to use society name (SPEBSQSA) within the chapter's name.

 - → Trying to better organize expenses by committee instead of by project, in order to get better visibility for how money gets spent
 - → Observation from Bill Miller that "new" format for financial reporting needs to provide more detail

 - \rightarrow Locations in play:

 - 5 Points venue

 - problems there with the venue we had to build that stage and it got very expensive
 - Still looking for a better venue choice
 - Decatur
 - they don't have a really good venue, unfortunately

- 14. IDAH update 2015 and beyond Terry Ludwig and Tim Pashon
 - \rightarrow Update provided by Rich Hansen
 - \rightarrow Forefront, Vocal Spectrum, After Hours all will be present
 - → Dave and Sandy Wright will be present
 - → Note that IDAH location was already locked in (Park Regency, Bloomington, in February), when the Spring HOD voted to drop the Spring Convention. Because of this, the 2015 IDAH won't be much different. "IDAH +" will happen in 2016 (along with a date actually in the Spring)
- 15. HOD for Spring 2015?
 - \rightarrow still has to happen twice a year thus the Spring HOD will have to be IDAH

Membership Report

August 16, 2014

The attached charts show how IL District chapters have fared in the last few years. The big story remains "non-renewals." Each Chapter Development Officer/VP Membership needs to keep his finger on "ebiz.barbershop.org" to see who in his chapter is nearing his renewal date (and hasn't done it). (See charts, 2/3 of way across, column titled 2014 NR".) NR's are slowing down, less this year than the last two, but we're still losing members! THOSE MEMBERS NEED TO BE ENCOURAGED TO RENEW! IT'S PARTICULARLY AT RENEWAL TIME THAT MANY ARE STRUGGLING WITH THE QUESTIONS SURROUNDING WHETHER THEY WANT TO RENEW. DON'T LET THOSE MEMBERS THINK THEIR CHAPTER DOESN'T CARE ABOUT (unless you don't---that's a joke).

The national Membership Committee advice regarding membership has been a general encouragement to all chapters to "get out in the community and show what you are and can do." Don't hide your light within the confines of your meeting hall! Perform! If you don't have gigs, find places to perform. Brainstorm where you could perform. Seek out places where your performances would catch the eyes and ears of potential male barbershop singers. Ask to perform, then do so--in style!

The most successful "program" in the society for increasing chapter membership (one at a time) is not the podium cattle calls of "Wives, get rid of your husbands on Thursday nights! Send them to us!" but rather, personal invitations, particularly using the "Super-charging Your Chapter" method (this year, the creator of that initiative was on the faculty at Harmony University at Belmont University in Nashville) by initiating a closely-scripted, five-minute interaction with a prospective member, inquiring about their singing. (Copious details available via barbershop.org, Supercharging Your Chapter, and on Facebook.) Chapters should maintain an electronic presence, so singers trying to check out chapters in your area will find you in the most common ways they're looking these days.

As always, I'm eager to hear (and receive as emails) stories of your chapter's triumphs, losses and support needs—particularly all those strategies you believe are paying off.

From Dave Cowin, Vice President Contests and Judging. Illinois District 9/5/2014

Our chapters and quartets have responded quite well to our first ever "Annual" Convention format. As of Friday, 9/5/2014, we have 16 quartets and 10 choruses entered in our combination of Illinois District and International Pre-Lim Contests. This includes 1 Collegiate Quartet entered in our International Collegiate Pre-Lims.

This year, I revived our "Most Improved Chorus" chorus contest. The rules for this contest are quite simple. The winner is that chorus whose score this year is the highest percentage improvement on their most recent score from the past 3 years' contests. If a competing chorus hasn't competed in the past three years, they will be establishing their base score for future year's most improved chorus contests.

There are 3 other Districts who have now changed their contest format to an annual, single fall convention. Those Districts are RMD, NED, and SWD. The NSC District only conducts a Fall Quartet contest and has their full conventions in the spring.

Brief comments were made regarding the Spring convention in Davenport, IA

A check of assignments and availability was made for those awards to be presented at the 2014 Fall convention (see attached spreadsheet). They include the following See attached grid

- ✓ The 2012 International Quartet Champions "Ringmasters" are touring the U.S. this fall and are slated to be the guests for two of our October festivals. They will be appearing in Charleston on the campus of Eastern Illinois University on Monday, October 20 and in Bloomington Thursday evening October 23 at the Bloomington Center for the Performing Arts. Both shows begin at 6:30pm.
- ✓ All grants for fall festivals need to be submitted by November 1st of the previous year to be eligible for funds from the Harmony Foundation. - ✓ All YIH event sponsors are required to submit a list of names and email addresses of their workers to BHS to take the updated sexual molestation prevention training video – which can be done individually at home. Each worker will have to take the test online and submit their quiz answers to BHS. The list of workers at the festival then needs to coordinate with the list BHS has of those who have successfully taken the online training. Timing is important – this needs to be done well before the event itself. Grant money from BHS and Harmony Foundation require this now!
- ✓ All event sponsors should submit their event to the district calendar and alert the DVP of YIH and District President and Treasurer (if requesting funds to help defray costs) in advance of the budget approval for each year.
- ✓ All festival coordinators receiving district monies should submit to Jim Wagner (district treasurer) an expense form that shows expenses and income within two weeks after the conclusion of the event.
- ✓ It has truly been an honor to serve as your DVP of YIH over the years. As I move into the presidency of the district for 2015-2016, I have asked Kevin Deets of the Sterling-Rock Falls Chapter to be my replacement on the operations team. He brings a wealth of YIH experience and I welcome him aboard.
